Secretary stated that the mission aimed to empower officials and the community with knowledge and skills for effective grassroots action. She emphasised that the programme represented a long-standing commitment towards people, rooted in inclusiveness, transparency, and service.

She further underscored that the State-Process Lab would be a space where vision would take shape. She mentioned that it would allow people to test new approaches, refine their local wisdom, and scale them to benefit the entire state.

DC Soreng chairs NCORD monthly review meeting

Soreng, August 30: Monthly review meeting of the Narco (NCORD) Coordination Committee for Soreng District was held today in a hybrid format under the chairmanship of Mr Dhiraj Subedi DC Soreng with several members joining the session virtually at DAC Soreng.

expressed appreciation for their continued commitment in combating the issue of drug abuse. He highlighted the growing challenges of substance abuse in the district and underlined the urgency of the matter. He emphasised that curbing the menace requires comprehensive approach involving strict enforcement, preventive measures, community awareness and effective rehabilitation.

He also reviewed the progress made by each department and sought updates on actions taken so far. Key issues discussed included police reports on drug seizures, cases

registered under NDPS and SADA, identification of hotspots and vulnerable areas, as well as uprooting of cannabis. Other matters taken up were border security, joint inspections, sensitisation programmes, enforcement work by the Excise Department, awareness drives in schools and colleges under and Education Health Departments, initiatives by NGOs and the Social Welfare Department and awareness activities carried out by driver associations.

The role of the Narcotics Control Bureau (NCB) was also discussed. A representative from NCB outlined its functions, including drug law enforcement, supply reduction, investigations, seizures, arrests and awareness campaigns. The DC recommended that training for public prosecutors be included along with that of magistrates and suggested that IEC materials be provided to create stronger visibility of NCB's presence and efforts in the district.

During the meeting, the house also discussed on challenges faced by rehabilitation centres, particularly inconvenience experienced by patients and the lack of trained counsellors at Primary Health Centres. The need to establish a dedicated rehabilitation centre in Soreng district, with the involvement of District Administration, was strongly highlighted. Proposals were also made to organise inter-school activities such as wall painting, street plays and graffiti competitions under the banner of 'Nasha Mukt Bharat Abhiyaan' to spread awareness among the youth.

The meeting had the presence of ADC-I, ASP Soreng, SDM (Hq), Joint Director (Education), DFO (T), Senior Welfare Officer, MO I/C, Officers and officials of various line departments, representatives of NGO and representatives of driver associations.

DC Soreng chairs coordation meeting

Soreng, August 30:A coordination meeting with Agriculture and Horticulture Departments was convened at Rurban Complex, Soreng, under the chairmanship of Mr Dhiraj Subedi DC Soreng, today.

The meeting was held to deliberate on the utilisation of barren lands and explore strategies for their productive

The DC enquired about present status of barren lands, initiatives undertaken so far and the availability of data. He emphasised that reviving unused land is a priority in line with the vision of the Chief Minister Mr Prem Singh Tamang, to enhance agricultural productivity and improve the livelihood of farmers.

In addition, DC placed step-by-step suggestions for implementation. He stressed on the importance of identifying and categorising barren lands across the six blocks and creating a comprehensive database with measurable outcomes. He called for soil testing and simplified analysed reports so that local farmers can easily understand the results and make informed choices. He also suggested that Government institutions could adopt and oversee cultivation on revived lands. He further highlighted the need to identify both suitable and alternative crops, with a focus on exotic and high-value varieties, while also exploring new opportunities under the Aspirational District Programme (ADP).

He emphasised on the strengthening of marketing chains, along with proper branding, packaging and promotion of local products. He urged departments to support local farmers by advertising and creating stronger market linkages for their produce. To ensure feasibility and sustainability, he suggested joint inspections with experts to assess crop suitability barren lands recommended maintaining updated data on a regular basis. He also stated that such coordinated efforts are vital not only for reviving barren lands but also for ensuring long-term benefits for farming community. He called upon all departments to work closely together and implement the strategies systematically to achieve tangible results for farmers and the

A detailed report on Barren Land Survey was presented by Mr Manish Pradhan Deputy

Director. The report provided a comprehensive overview of surveys undertaken across various blocks under Soreng district to identify barren lands. It also outlined the total number of farmers from each block, their areas of interest and feasible crops suited for cultivation. The action taken by the Agriculture and Horticulture Departments highlighted documentation of field visits, technical support through soil analysis and recommendations.

The report further noted that barren land revival efforts are already in progress. Several farmers have successfully cultivation on initiated previously unused lands, adopting crops such as Cherry Pepper and Turmeric. Okhrey GPU was specially recognised as a model of success, where 0.5 hectares of leased barren land was rejuvenated through the cultivation of Garden Pea and Cabbage, supported by training from ATMA, Soreng District.

Mr DR Bista ADC shared several proposals under the barren land rejuvenation initiative. He highlighted the importance of potential crop identification and cited the example of reviving apple cultivation in the Hilley area. He further, suggested promoting coffee plantation initiatives, along with the development of nurseries for horticultural, agricultural and forestry purposes. The proposals also included the sourcing of highvalue seeds, production of vermicompost and organic manure with proper branding and packaging, and exploring opportunities to market these products outside the state. He also emphasised the scope of cultivating Chayote noting that the climatic conditions of Soreng are highly suitable for its largescale plantation. Several other innovative proposals were also put forward to strengthen the initiative.

The meeting also had the presence of Mr Pranay Gurung Additional Director Agriculture Department, Mr Bhanu K Pandey Deputy Director Horticulture Department, Mr Bhanu K Chettri and Mr Rota Sunar Deputy Directors Horticulture, Mr Manish Pradhan and Mr AB Rai Deputy Directors Agriculture, Mr Bikash Bhattarai HDO Horticulture, VLWs and Agriculture Inspectors.

This was followed by the second session led by Mr Vishal Biswakarma, ISL Interpreter, who elaborated on deaf and audible range cultures, methods of forming signs, communication techniques,

Press Release from Science and Technology Department

Mangan, September 1:A multidisciplinary scientific team concluded an extensive field mission in North Sikkim from August 26-September 1, 2025, focusing on glacial lake assessments and sediment studies following recent flood-related events in the region.

Starting from Muguthang on Day 6 of the mission, the team reached South Lhonak by Day 8, where a ceremonial pooja was held at Chimigyader and at the lake itself to invoke blessings for a safe and successful operation.

At South Lhonak (17200 ft), the team conducted bathymetric studies, fixed pressure probes and collected post-flood sediment samples critical for ongoing glacial lake outburst flood (GLOF) risk assessments.

Following the completion of studies at South Lhonak, the scientific personnel from Himachal Pradesh, NIH (National Institute of Hydrology), CWC (Central Water Commission), DGRE (Defence Geoinformatics

Research Establishment), and GSI (Geological Survey of India) departed after fulfilling their objectives.

The remaining members advanced to Changsang Lake (18100 ft), where they carried out further bathymetric mapping and performed a detailed morphometric analysis of the lake's terminal moraine an essential feature in assessing the stability and hazard potential of glacial lakes.

On September 1, the team reached Thangu, where preparations began to study Yuleh Khangse Lake, located above Lashar Valley, in continuation of the broader glaciological and hydrological research mission.

This expedition forms a vital part of India's growing efforts to monitor Himalayan glacial systems and enhance early warning mechanisms against GLOFs and other climate-induced hazards in high-altitude regions.
