Sikkim observes Disaster Risk **Reduction Day**



Gangtok, September 18: Sikkim State Disaster Management Authority (SSDMA) under Land Disaster Revenue and Management Department (LRDM), observed the commemoration of September 18, 2011 Earthquake and State Disaster Risk Reduction Day at Chintan Bhawan, Gangtok, under the theme 'Empowering Communities, Safeguarding Secretary-cum-Chairperson of

Sikkim', today.

The programme was attended by Chief Minister Mr Prem Singh Tamang, who is also the Chairperson of SSDMA.

He was accompanied by Mr Sonam Lama Minister for Public Health Engineering Department, Mr LB Das MLA-cum-Advisor LRDM, Mr R Telang Chief

State Executive Committee (SEC), Mr Manish Bhardwaj Secretary National Disaster Management Authority, Professor VK Sharma Vice Chairman SSDMA, and Mr MT Sherpa State Relief Commissioner-cum-Secretary

The Chief Minister highlighted the significance of observing September 18 as State Disaster Risk Reduction Day, recalling the devastating earthquake of 2011 and the South Lhonak Lake Glacial Lake Outburst Flood (GLOF) of October 3-4, 2023 that not only tested the strength but also revealed the resilience of the people of Sikkim.

He stated that this day carries emotional significance and serves as a reminder to strengthen collective preparedness.

The Chief Minister underlined Sikkim's unique geographical vulnerabilities, including earthquakes, landslides, and glacial risks, which demand a

Block Level Orientation Programme for Village Master Trainers concludes

Namchi, September 20:Block Level Orientation Programme for Village Master Trainers under the Aadi Karmayogi Abhiyan concluded today at PM SHRI Girls' Senior Secondary School, serving as the Block Process Lab-Namchi, today.

The programme was organised under the Aadi Karmayogi Abhiyan of the Ministry of Tribal Affairs, Government of India, empowering individuals and strengthening institutions towards achieving comprehensive tribal development.

Ms Tirsang Tamang ADC Namchi directed the trainers to implement the two-day programme plans in the tribal villages. She instructed the VMTs to ensure that tribal schemes are effectively benefiting the tribal communities and that the intended support reaches the rightful beneficiaries.

She also emphasised the importance of disseminating information about the two-day campaign to all tribal villages.

Mr Upendra Rai BDO Namchi urged the trainers to raise awareness about the initiative among wider community.

He highlighted that the Aadi Karmayogi Abhiyan (AKA), is a flagship initiative of the Ministry of Tribal Affairs, which aimed at strengthening grassroots governance and planning in tribal areas. The AKA programme focuses on building the capacity of VMTs to prepare village-level action plans through participatory methods, ensuring inclusivity and respect for tribal traditions and sentiments.

He informed that by addressing gaps in development plans and promoting community-driven solutions, the Abhiyan strives to achieve inclusive tribal transformation and sustainable development.

Also, he provided a briefing on the 'Pradhan Mantri

Jan Dhan Yojana', a national financial inclusion scheme aimed at ensuring access to basic banking services for all, especially the tribal communities.

Moreover, he explained that the scheme provides savings accounts, direct benefit transfers, insurance coverage, and access to credit, helping tribal families become financially empowered. The campaign under this scheme is intended to promote overall community development, enabling the tribal population to access government benefits efficiently, manage their finances, and improve their livelihoods.

Ms SM Tamang Block Master Trainer (BMT) reviewed the sessions and activities conducted on the previous day. The discussions covered several important aspects, including leadership, formation of intergroups for activities and reflective exercises.

Ms Sangita Pradhan Junior Facility, SIRD & PR delivered a detailed presentation on Participatory Rural Appraisal (PRA), highlighting its significance as a planning and processing tool for tribal villages.

She elaborated on PRA tools, including social mapping, transect walks, household surveys, venn diagrams, resource mapping, focus group discussions, and seasonal calendars, emphasising social and resource mapping as key tools.

Further, she explained that Aadi Karmayogi Abhiyan launched in 2024, aims to work towards the vision of tribal villages through 2047.

Mr Sonam Dadul Bhutia Social Welfare Officer-cum-Nodal officer Aadi Karmayogi Abhiyan briefed on the initiative under which 22 villages in Namchi District are included. He emphasised the importance of inclusivity, ensuring that every tribal community is equally represented and involved.

Also, he instructed VMTs to visit the concerned villages directly to prepare these plans, ensuring that all members of tribal communities are treated equally.

He further stressed that the sentiments of tribal communities must be safeguarded, and that the teams should function collaboratively. Village action plans are expected to be submitted by October 2, with planning and execution taking place within the respective villages.

He also mentioned that if necessary VMTs may directly consult with the relevant departments to incorporate their inputs into the village plans.

The concluding day saw a mock Participatory Rural Appraisal (PRA) activity, which was the highlight of the second day programme during which the VMTs prepared village maps. These maps were categorised into resource maps and social maps, serving as a practice exercise to prepare, refine and simulate the actual PRA process before conducting it in the field.

This exercise helps strengthen the VMTs' skills, ensures methodological clarity, builds confidence, and enhances the effectiveness of their engagement with the community, ultimately leading to better outcomes.

The orientation programme concluded with the distribution of certificates to the Village Management Trainers (VMTs) in recognition of their successful participation.

The programme was also attended by Mr Ramesh Chand Chandrawal Under Secretary Ministry of Tribal Affairs and District Prabhari Aadi Karmayogi Abhiyan for Sikkim, Mr Arun Kumar Rai AEO, Ms Bandana Rai Principal PM SHRI GSSS, Ms Seden Ongmu Bhutia AEO Namchi Education Deptt/DMT and others.

Jorethang Rural ICDS project observes 8th Rashtriya Poshan Maah

Namchi, September 19:
Following the launch of 8th Rashtriya Poshan Maah (National Nutrition Month) on September 17, a month long campaign dedicated to promote and advocate awareness on nutrition and health and wellness to the community, a Poshan Walk event was organised by the Jorethang Rural ICDS Project, under Women, Child, Senior Citizens and Divyangjan Department at Jorethang, today.

During the event, Mr Samten Moktan Panchayat NJNP emphasised the critical need for every individual to adopt a healthy lifestyle. He also highlighted the State Government's commitment in strengthening the health sector, referencing Chief Minister vision and various initiatives, schemes and infrastructure projects.

Further, he urged all Anganwadi Workers (AWWs), Anganwadi Helpers (AWHs), ASHA workers and other health personnel to work with utmost dedication. He encouraged them to promote nutrition and wellness among the public through broader outreach programmes.

He stated that the Panchayat, as a governing body, is always prepared to support the department in future campaigns.

In her address, Ms Uma Portel Panchayat NJNP, emphasised the need to adopt and advocate the oaths taken during the pledge at individual levels and also creating awareness among the mass for health and wellness and adopting nutritional diet consumptions. She also stated that the message being proclaimed during the period of the month-long Poshan Maah should have a positive impact through larger awarness and outreach campaigns.

She urged to work in tandem with line departments to develop and lead the rural areas towards healthy environment.

Earlier, Mr Prabin Silal CDPO Jorethang briefed about the present Poshan Maah's themes under the mission to improve nutritional outcomes and holistic developments leading to healthy community and environment.

He also highlighted the themes, stating that the mission aims to address key focus areas such as combating obesity targeted to reduce sugar and oil consumption, Early Childhood Care & Education (ECCE) where nutrition is integrated with early learning under Poshan Bhi Padhai Bhi (PBPB), Infant & Young Child Feeding (IYCF) that promotes breastfeeding complementary feeding practices, men-streaming that encourages active involvement of male in nutritional care and health practices, Ek Ped Maa Ke Naam plantation campaign and Vocal for Local endorsing local produce and traditional cuisine.

Earlier, Mr Samten Moktan administered the Poshan Pledge. A signature campaign was also observed during the event.

Mangan District organises Rashtriya Poshan Maah

Mangan, September 20: As part of the Rashtriya Poshan Maah 2025, Mangan District organised a series of community-based activities under the theme 'Poshan Walk' aimed at promoting awareness around nutrition, health and early childhood care.

The walk was conducted at village level, involving local stakeholders, AWWs, AWHs, Supervisor, CDPO, SHGs and community members.

The walk served as a platform to disseminate crucial information on good nutrition emphasising the importance of a

healthy, balanced diet, especially for pregnant and lactating mothers, children, and adolescents.

The objective of the 'Poshan Walk' was to generate awareness and mobilise the community towards achieving the goals of POSHAN Abhiyaan, which seeks to improve nutritional outcomes for children, pregnant women, and lactating mothers. The grassroots-level outreach ensured that messages reached every household, reinforcing the importance of health, nutrition, and education from the early years.

Stakeholder training on enforcement of COTPA 2003 organised

Pakyong, September 20: A one-day stakeholder training on the enforcement of Cigarettes and Other Tobacco Products Act (COTPA), 2003 was organised by Health and Family Welfare Department, Pakyong District, at Rurban Community Complex, today.

The objective of the programme was to strengthen the implementation of COTPA by enhancing awareness among stakeholders, ensuring effective enforcement of its provisions and protecting the public.

Highlighting the correlation between tobacco use and tuberculosis, Dr Madanmani Dhakal, Chief Medical Officer Pakyong, explained the different types of TB and serious health risks associated with smoking. He elaborated on how smoking weakens the lungs, increasing susceptibility to TB and explained the role of nicotinic receptors in tobacco addiction. He stressed that enforcement of COTPA is crucial to safeguard passive smokers from involuntary exposure to tobacco smoke.

Dr Pema Doma Sherpa, AD Sanitation, District Hospital Singtam, delivered a detailed presentation on the harmful effects of tobacco use, including the risks to passive smokers. She also explained key legal provisions relevant tobacco control, highlighting the Juvenile Justice Act, Section 77, which prohibits giving or causing a minor to consume addictive substances, including tobacco, with violations punishable by a fine of up to ₹1,00,000/- and imprisonment for up to seven years. She further referred to the Indian Penal Code, Section 268, which defines creating a public nuisance that endangers or annoys the public and carries a fine of ₹200/-, and the Food Safety and Standards Act, 2006, which incorporates restrictions related to tobacco products. In addition, she explained the regulations for designated smoking zones in establishments with a seating capacity of 30 or more or with 30 or more rooms.

She further elaborated on the key provisions of the

COTPA Act, explaining that Section 4 prohibits smoking in public places, while Section 5 restricts all forms of tobacco advertisements. highlighted that Section 6(a) bans the sale of tobacco products to or by minors and Section 6(b) prohibits the sale of such products within 100 yards (91 meters) of educational institutions. She also spoke on Section 7, which places restrictions on the production, supply and trade of tobacco products and Section 8, which mandates the display of health warning labels on all tobacco packaging.

Dr DP Koirala, District Nodal Officer, NTCP Cell, emphasised the importance of COTPA in reducing tobacco consumption and its associated health risks. He explained how nicotine leads to addiction and highlighted the severe health threats posed by tobacco use.

Furthermore, Dr Digcha Shree Rai, Programme Coordinator, NTCP Pakyong, gave a presentation on the objectives, provisions, and enforcement mechanisms of the COTPA Act, 2003. She spoke about strategies such as public awareness campaigns and enforcement by police, health, and municipal authorities. She also presented case studies on COTPA violations in Sikkim, highlighting both success and stories ongoing challenges.

Dr Chogyal Bhutia, President, gave an overview of the National Tuberculosis Elimination Programme (NTEP) and Sikkim's commitment to eliminating TB by 2025. He explained the symptoms of pulmonary TB, differences between TB infection and TB disease, modes of transmission, and diagnostic methods. He also detailed treatment regimens for drugsensitive TB (DS-TB) and TB infections.

The programme was attended by officials from Forest and Environment Department, Health and Family Welfare Department, teachers and stakeholders from Pakyong.

For items outside the SOR, the rates shall be as per the technically checked estimate/analysis. Decision of the Principal Chief Engineer/Head of the Department will be final in this regard.
- 10. The work value, scope and quantum of work are subject to change, the contractor shall execute the work as per the directives of the Department. No claim on this account shall be entertained whatsoever. If any extra claim is made, it shall be as per the agreement rates.
- 11. The contractor shall engage a Graduate/ Diploma Civil Engineer(s) at the project site during the period of execution of work as per the norms prescribed in the Enlistment Rules and grade of contractors as well as requirement site determined by Engineer-in-charge.

culture of safety and sustainable practices.

He further informed that under SSDMA, significant strides have been made in integrating disaster risk reduction into development planning.

other international institutions, initiatives such as multi-hazard risk assessments, landslide studies, and scientific monitoring of glacial lakes have been undertaken.

Early warning systems, high-altitude expeditions, and capacity-building programmes are strengthening the State's preparedness and response framework.

Through the Aapada Mitra scheme and induction of disaster coordinators, management supervisors, and assistants at various levels, disaster preparedness has also been ensured at the grassroots.

Notably, 1,185 officials have been inducted into SSDMA and trained through rigorous exercises to serve as the backbone of Sikkim's disaster management

Recalling the South Lhonak Lake Glacial Lake Outburst Flood (GLOF) of October 2023, which had a severe impact on lives, infrastructure, and the tourism sector, he stated that following a post-disaster assessment, the Government of India has extended In partnership with NDMA substantial financial support for relief and reconstruction, with restoration works underway.

> He added that while progress is being made, Sikkim's fragile Himalayan ecosystem demands sustained attention and resources, and the State continues to seek further assistance from the Government of India to strengthen its disaster response capacity.

Expressing gratitude to the Prime Minister, Government of India, NDMA, SDRF, NDRF, armed forces, various State Government Departments and civil society organisations for their continued support to Sikkim in times of disaster, the Chief Minister stated that disaster preparedness is a shared responsibility.

Concluding his address, the Chief Minister reaffirmed the State Government's commitment to building a disaster-resilient Sikkim and called for collective action to safeguard lives, livelihoods, and the environment.

Mr Manish Bhardwaj, in his address lauded Sikkim's resilience and disaster preparedness. He stated that Sikkim has prepared district-level and state-level disaster management plans that reflect strong institutional readiness of the state.

Referring to the South Lhonak Lake GLOF of October 2023, he said recovery is guided by the principle of 'building back better' with a focus on restoring livelihoods, strengthening early warning systems and protecting ecosystems.

He highlighted initiatives like the National Landslide Risk Management Programme, National Glacial Lake Risk Mitigation Programme, earthquake retrofitting of infrastructure, and training of engineers and artisans in safety techniques.

Chief Secretary stressed on the importance of preparedness and community participation in disaster management. He highlighted the State's vulnerability to earthquakes, landslides and climate-induced changes, noting the shift in rainfall patterns due to climate change.

Referring to the 2011 earthquake and the GLOF of 2023, he said Sikkim has learned from past disasters to strengthen its resilience, including disasterresilient housing, school safety, and village-level volunteer training.

Stressing that personal safety must become a habit, he called for building a culture of preparedness through education, data collection, and community engagement.

Professor VK Sharma, emphasised that since the 2011 earthquake, Sikkim has steadily strengthened its disaster preparedness through annual observance of State Disaster Reduction Day and innovative resilience initiatives.

He highlighted the State's pioneering steps in disasterresilient housing, health and school infrastructure, and training of community-level volunteers.

Stressing the importance of scientific monitoring, local data collection, and youth engagement, he added that Sikkim today stands as a model of community-driven disaster resilience for the nation.

Mr MT Sherpa Relief Commissioner-cum-Secretary highlighted Sikkim's vulnerability to disasters and outlined State initiatives such as trained disaster personnel, early warning systems and integration of risk reduction in development planning. Stressing collective responsibility, he called for building resilience at every level of society.

On the occasion, the Chief Minister was felicitated for the formation of the Sikkim State Disaster Management Service cadre, marking a significant milestone in strengthening disaster management architecture.

The felicitation ceremony also honoured six best disaster management trainees from each district of the State for their exceptional performance during

their 12-days residential training on 'Basics of Disaster Management'.

As part of the felicitation ceremony, winners of the Inter-College Quiz Competition on 'Disaster Risk Reduction' were also awarded.

The programme also featured a video presentation, highlighting Sikkim's journey in disaster management over the years. Another presentation showcased the training activities of disaster management officials.

It may be mentioned that in line with the Chief Minister's vision of building a dedicated disaster management team across Sikkim, 1,185 disaster management officials have been recently inducted into SSDMA.

These officials have undergone intensive capacitybuilding programmes, including simulations and specialized training at the Mountaineering and Adventure Institute of Sikkim, Yuksom, and the Indian Himalayan Centre for Adventure and Ecotourism, Chemchey, equipping them to respond swiftly and effectively during crises.

With the qualifying date set, the process involves enumeration, verification, draft publication, and final roll preparation.

The Orchidarium, a one-of-a-kind destination dedicated to the world of orchids, is spread across two lower levels of the Swarna Jayanti Maitreya Manjari. It features a state-of-the-art, climate-controlled environment housing a rich and diverse collection of orchids. Approximately 70% of the exhibit comprises live orchid specimens, while the remaining 30% consists of detailed botanical

models, showcasing species from across the globe.

Visitors can explore the Wonderland Orchid Hall, an engaging display area, along with a museum that provides in-depth insights into orchid biodiversity, conservation, and cultivation. Among the highlights are native orchids from Sikkim, including the state flower Dendrobium Nobile, Cymbidium Namo, and a rare orchid variety named in honour of Prime Minister Mr Narendra Modi.

The newly introduced QR-based ticketing and automated gate system is aimed at enhancing the visitor experience by enabling smooth, contactless entry. The Orchidarium is officially open to the public starting today.

Outreach programme on GST reforms

Gangtok, September 21: The outreach programme for dissemination of new generation GST reforms, jointly organised by CGST and Central Excise Commissionerate, Siliguri, Government of India and Commercial Taxes Division, Finance Department was held at Chintan Bhawan, today.

Dr Nirmal Joy Joint Commissioner CGST Siliguri Commissionerate made a presentation on the next generation of GST reforms by the 56th GST Council Meeting, highlighting key changes and their implications. He informed that the Council Meeting was held in New Delhi on September 3, under the chairmanship of Ms Nirmala Sitharaman Union Finance Minister, Government of India and in accordance to the Independence Day 2025 address of the Prime Minister, the 'Next Generation GST Reforms' were announced.

The goals of these reforms include rationalisation of GST slabs to reduce burden on citizens and ease compliance. The detailed presentation covered an overview of reforms, major structural changes in GST rates, sectoral overview on rate changes, highlights on rate reforms, and relief in health, insurance and agriculture. GST has been exempted on all individual life and health insurance policies. Rates on 33 lifesaving drugs have been reduced from 12% to nil and 3 from 5% to nil. Medical devices and apparatus have been reduced to 5%. GST has also been reduced from 12% to 5% on tractors and farm equipment. A slide was also presented on how these reforms empower the MSME sector. Items moved to higher tax slabs were also discussed.

He spoke on procedural reforms for trade facilitation, which included GST refunds for low-value export consignments,

risk-based provisional refunds (zero-rated supplies), risk-based refunds for inverted duty structure, simplified registration GST scheme for small and lowrisk businesses effective November 1, 2025, amendment in place of supply for intermediary services, clarifications on postsale discounts, annual return exemption for small taxpayers, and GST Appellate Tribunals. He concluded with the expected impacts and benefits of the new reforms. Public notice no. 06/ 2025 issued by the Office of the Commissioner of Central Goods and Service Tax, listing nodal officers under Siliguri Commissionerate to assist trade, was also shared.

Mr Dorjee Wangchuk, Joint Commissioner, Commercial Tax Division presented a PPT on the rationalisation of rates and its implications on ITC. He explained that manufacturers, packers or importers of prepackaged commodities are permitted to declare revised sale prices (MRP) on unsold stock due to the change in GST rates of goods and services. The advisory issued by the Department of Consumer Affairs on September 18, 2025, superseding the earlier advisory dated 9th September 2025, was also discussed.

This was followed by an open interaction among stakeholders, moderated by Mr Manoj Rai Commissioner Commercial Tax Division, and Dr Nirmal Joy Joint Commissioner CGST Siliguri Commissionerate.

The programme had the presence of Mr PK Das Assistant Commissioner CGST, Mr Abhimanyu Maji Superintendent, Mr Pushkar Kumar Inspector CGST Commissionerate Siliguri, along with Chartered Accountants, Advocates, Tax Practitioners, officials from various corporations, trade associations, and stakeholders.
