Sikkim showcases Orchid wealth to Prime Minister

Gangtok, April 28: Prime Minister Mr Narendra Modi visited the Swarna Jayanti Maitreya Manjari at Ridge Park, Gangtok, placing national focus on Sikkim's distinctive model of environmentally sustainable development and its rich ecological heritage as the State celebrates the closing 50 years of statehood celebrations, today. He was accompanied by the Governor of Sikkim, Mr Om Prakash Mathur, and Chief Minister Mr Prem Singh Tamang.

The project conceived as part of the Golden Jubilee commemorations, had been virtually inaugurated last year by the Prime Minister during the formal launch of the year-long celebrations. Developed as a 26-foot tall copper structured monument, the Swarna Jayanti Maitreya Manjari serves as a cultural plaza symbolising five decades of Sikkim's integration and growth.

Located at Ridge Park near White Hall, the complex blends cultural symbolism with ecological consciousness. Its defining feature is the Orchidarium a state of the art, climate controlled Cool House spread across two levels housing over 100 species and



showcasing a wide range of native and exotic orchids. Nearly 70 per cent of the collection comprises live specimens, while the rest includes detailed botanical models representing global diversity.

Among the highlights are indigenous species such as Dendrobium nobile, alongside Cymbidium NaMo. A rare orchid

Bi-Annual AAC meeting held

Pakyong, April 22: Airport Advisory Committee (AAC) convened its bi-annual meeting at Pakyong Airport to review the current status of airport operations and deliberate on the resumption of passenger flight services.

The meeting chaired by Dr Indra Hang Subba MP Lok Sabha was attended by Mrs Pamin Lepcha MLA Gnathang-Machong Constituency. The session brought together key stakeholders, including senior government officials, administrative authorities, airport and security personnel, and representatives from trade and local associations.

Also present were Mr CS Rao Additional Chief Secretary, Tourism and Civil Aviation Department, Mr Agawane Rohan Ramesh District

Collector, Pakyong, DFO, Pakyong, General Manager, NHIDCL and Mr Nakul Das Rai former Member of Parliament.

Representing airport and security authorities were Senior Superintendent of Police, Pakyong District, Airport Director, Pakyong Airport, and Chief Airport Security Officer (CASO), Sikkim State Police. The meeting also saw participation from industry and local representatives, including OSD, IT Department and others.

The primary focus of the six-month review meeting was to address public and administrative concerns regarding passenger flight operations. Detailed discussions were held on key issues such as the resumption of flight services, operational challenges faced by the airport,

infrastructure requirements, and strengthening of security measures.

Officials from the Tourism and Civil Aviation Department, District Administration, Police, and Airport Management shared inputs and suggestions to improve coordination and streamline operations. Representatives from the trade, tourism, hotel, and transport sectors also highlighted the impact of disrupted air connectivity on economic activities and emphasized the need for timely restoration of services.

The Committee expressed a collective commitment to resolving existing operational hurdles through coordinated efforts.

Soreng District initiates coordinated Action Plan for traffic, road safety and infrastructure management

Soreng, April 22: A joint meeting of the District Level Decongestion, Road Infrastructure and Road Safety Committee was convened today at the office of Mr Dhiraj Subedi District Collector at District Administrative Centre (DAC), Soreng, to deliberate on issues concerning traffic decongestion, road safety, and road infrastructure management in Soreng District, particularly within Soreng Nagar Panchayat.

The DC highlighted the gradual strain on existing road infrastructure, which has contributed to increasing parking challenges and traffic congestion in and around Soreng town. The transition of the area into a semi-urban Nagar Panchayat was also noted, necessitating structured planning and coordinated interventions.

A detailed assessment of traffic congestion was undertaken, with emphasis on decongesting major approach roads leading into Soreng town. It was discussed that this would involve systematic assessment of households' encroachment upon road reserves, while also ensuring that carriageways are kept clear for smooth vehicular movement. The need to identify specific congestion points for targeted and workable action was also highlighted. In this regard, it was decided that a comprehensive survey would be conducted on May 5 for identification of affected areas and formulation of suitable short-term and long-term remedial measures. The DC mentioned that the survey would be conducted by a team comprising the ADC, ASP, ADC (Development), DFO, SE (Roads), Deputy RTO and Bazar Officer (UDD), along with participation of the Nagar Panchayats.

Further, it was deliberated that, if required for the purpose of effective decongestion and

ensuring smooth traffic movement, provision and submission of building blueprints to the Urban Development Department may be considered as a regulatory measure. This would facilitate better planning and enable the public to comply with prescribed building norms and regulations.

The meeting discussed decongestion strategies including both immediate and long-term measures. Short-term interventions such as traffic regulation, road markings, and enforcement of no-parking zones were emphasised, with road markings identified as a crucial immediate step. Long-term strategies included road widening and planning for designated parking zones. It was also discussed that both short-term and long-term parking management plans would be implemented, including the identification of authorised and unauthorised parking spaces and the proposal of dedicated long-term parking zones.

For public transport and mobility improvement, SP informed that regulatory measures are being undertaken, including restriction of heavy vehicle movement during working days between 9 AM-11 AM to ease congestion. The importance of maintaining traffic discipline among the public was also reiterated.

Road safety was comprehensively reviewed, with a coordinated approach among all concerned Departments emphasised. Requirements for essential road safety equipment were identified and noted for installation. The meeting also emphasised the importance of maintaining proper drainage systems, particularly following construction activities, to prevent waterlogging and ensure safety during the

upcoming monsoon season. Additionally, concerns were raised regarding pipelines laid through drainage channels, which cause blockages and lead to flooding of roads.

Issues related to construction materials being left along roadsides were also discussed, as these pose risks to both traffic flow and safety. The Police Department informed that such issues are being addressed through regular beat and mobile patrolling.

The meeting also reviewed the use of technology in traffic management, noting that 23 CCTV cameras are currently operational within the area, contributing to monitoring and enforcement efforts.

Public awareness and community participation were identified as critical components in addressing congestion. The need for behavioural change, including sensitising nearby residents to opt for walking for short-distance errands on busy days, such as grocery shopping when possible, was highlighted as a practical step towards reducing traffic jams.

Representatives from Soreng Taxi Drivers Association, present in the meeting, shared their grievances and provided valuable feedback, which were acknowledged for consideration in future decisions and implementation.

The meeting concluded with a roadmap for the next course of action, wherein, the completion of the scheduled survey would inform both immediate and long-term interventions for effective traffic management and road safety in the district.

Present in the meeting were SP, ADC, SDPO, CMO, SE (R&B), DE (R&B), DFO (T), DPO (Zilla), DD (Education) along with representatives from the Soreng Taxi Drivers Association.

Meeting on 6th SFC and 15th CFC fund approval under e-Gram Swaraj Plan for 2025-26

Mangan, April 23: A meeting of the Mangan District Zilla Panchayat for discussion, allocation and approval of fund under 15th CFC and 6th SFC under e-Gram Swaraj Plan for 2025-26 was held at MDZP Bhawan, Mangan, today.

The meeting was chaired by Adhyaksha MDZP Mr Kado Lepcha, and had the presence of Ms Sonam Kipa Bhutia Up-Adhyaksha, Mr Sonam T Lachungpa Lachung Papon, Zilla Panchayats, Officials and staff from MDZP.

Mr Karma Thendup Bhutia Additional Secretary-cum-DPO, MDZP provided a brief overview of the meeting.

This was followed by a detailed presentation on the monthly progress report by Mr Karma Sonam Bhutia, DE MDZP, highlighting the overall physical and financial status of ongoing schemes and developmental works. The presentation covered progress achieved against targets, status of fund utilisation, scheme-wise implementation updates and key achievements recorded during the period.

Thereafter, the fund allocation under the 15th CFC and

6th SFC under e-Gram Swaraj Plan for the financial year 2025-26 was presented in detail by Ms Chusong Lepcha, Accounts Officer, MDZP, outlining the proposed distribution and sector wise allocation of funds.

The Annual Plan for 2025-26 was presented by Ms Phulden Bhutia staff MDZP, highlighting the key priorities, proposed developmental activities and implementation framework for the upcoming financial year.

Following the deliberations, Adhyaksha Mangan emphasised the importance of transparent fund allocation, effective implementation of development schemes and collective responsibility of all members to ensure balanced and sustainable development across the district.

The meeting was also addressed by Mr Sandeep Kumar SDM Mangan, on behalf of Mr Anant Jain, DC-cum-Sachiva, wherein he highlighted the need for maintenance and repair of key public utility infrastructure, including hostels in schools, viewpoints and other essential facilities, under the Vibrant Village Programme.

DC Namchi inspects EMRS Suntaley

Namchi, April 22: Under the supervision of Ms Anupa Tamling DC Namchi, a field inspection was conducted at Eklavya Model Residential School (EMRS), Suntaley, to assess the overall functioning of the institution and review progress of ongoing developmental works and essential facilities, today.

During the visit, the DC first inspected the water source in light of the reported shortage of water and reviewed the progress of the ongoing water supply works being undertaken for the school.

The inspection also covered several key infrastructure projects, including fencing works, staff quarters, the auditorium hall, football ground pavilion.

The school mess was also inspected to assess the quality of food being served to the students. Special emphasis was laid on maintaining proper hygiene standards and ensuring the provision of nutritious meals for the children.

During the visit, she checked all school registers and official records and directed the Principal to remain vigilant and ensure that all records are properly maintained and updated on a regular basis.

She encouraged and motivated the Captain Council to work collectively towards making the school one of the best among EMRS institutions in Sikkim.

Special emphasis was laid

on cleanliness and beautification of the school premises through plantation drives and proper maintenance of hostels, particularly the girls' hostel, which was directed to be kept clean and well-maintained at all times.

It was also brought to notice that medical camps, which had earlier been conducted regularly within the school campus, had not been organised for nearly a month. In response, she assured that a general health camp would be arranged shortly for the benefit of both students and staff.

Furthermore, she directed the Principal to ensure proper segregation and management of solid waste. She also instructed the Director (RDD) to facilitate the construction of a compost pit within the school premises for effective waste disposal and better waste management practices.

She also interacted with the teaching staff and expressed concern over the unsatisfactory Class X examination results. She urged the teachers to take greater responsibility and work closely with the Principal to improve the academic performance of the school in the coming academic session.

Present during the inspection were Panchayats, SDM (Hq), Deputy Director RDD Sumbuk, Principal EMRS and others.

Training on Hygienic Fish Processing and value addition held

Pakyong, April 23: A three-day residential training programme on Hygienic Fish Processing and Value Addition with Cold Chain and Market Linkage Support was held at Namcheybong GPK Hall, Pakyong, today.

The programme was organised by National Fisheries Development Board (NFDB), North Eastern Regional Centre, Guwahati under the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India, in collaboration with Fisheries Department.

The training was conducted for the participants from the Scheduled Caste category aimed to equip them with hands-on training in the preparation of value-added fish products and to create sustainable livelihood opportunities for them.

Mr Bum Tshering Yonzon

OSD, IT Department in his address highlighted on the Chief Minister's vision of uplifting the farmers through various schemes and initiatives and encouraged them to become self-reliant. He further urged the participants to acquire necessary skills and explore opportunities within the aquaculture sector to enhance their livelihoods.

Additionally, Ms Gauri Mukhia District Fisheries Development Officer emphasised that the training would enable the participants to explore diverse opportunities in fish value addition, while equipping them with practical knowledge. She elaborated on the various initiatives under the MMMUY and PMMSY schemes.

Further, Mr Sharad SP Executive Assistant, NFDB Guwahati outlined the objectives of the training, highlighting the

growing market demand and profitability of value-added fish products. He further stated that the fisheries industry and allied activities offer a vast potential for employment generation.

A Farmers' Meet was also organised wherein the resource person interacted with farmers, addressed their queries and shared information on benefits and subsidy schemes available under PMMSY.

A technical session was also conducted to provide the 25 trainees with guidance on the preparation of various value-added fish products.

The programme concluded with the distribution of testing kits and ice boxes to trout farmers from ICAR-CICFR, followed by the release of the hands-on training Manual for preparation of Value-Added Fish Products.

In exercise of the powers conferred under Section 16 of the **Sikkim Allotment of House Sites and Construction of Building (Regulation and Control) Act, 1985**, the Government of Sikkim hereby notifies the conversion of Parcha as Secondary holder into leasehold shall henceforth be subject to realization of a Lease Transfer Fee at the rate of **₹40/- (Rupees Forty only) per square foot**, as prescribed under the existing rules governing lease transfer.

This notification shall apply to all pending and future eligible cases and shall come into force with immediate effect from the date of issuance of this notification. All other terms and conditions governing lease transfer shall remain unchanged. Any action taken or fee realized prior to the issuance of this notification shall be deemed to have been taken or realised under the corresponding provisions in force at that time and shall remain unaffected.

This notification supersedes the notification issued vide memo no. T(1839)GOS/UD&HD/1164. dated:16.06.2021 published vide Gazette no. 113, dated: 18.06.2021.

The National Manuscript Survey 2026, scheduled from March 16 to June 15, 2026, is a nationwide initiative aimed at systematically identifying, documenting and preserving manuscript heritage across India. The survey is being implemented under the Gyan Bharatam Mission in coordination with State Governments and Union Territories, ensuring administrative efficiency, regional adaptability and uniform data collection practices.

The survey seeks to generate a comprehensive understanding of the distribution and condition of manuscripts across the country, thereby laying the foundation for future initiatives in preservation, digitisation and scholarly access. It represents a significant step towards safeguarding India's manuscript heritage through systematic fieldwork, institutional collaboration and the use of digital technologies.

At its core, the mission focuses on manuscripts handwritten compositions on materials such as palm leaves, birch bark, cloth, paper and metal. To qualify under the survey, a manuscript must be at least 75 years old and possess historical, scientific or aesthetic significance.

Mr Suresh Rai Additional District Collector (Gyalshing), chaired the meeting to ensure the district's enforcement mechanisms are robust, proactive and fully aligned with the goal of protecting vulnerable communities of the district.

The meeting was attended by the Addl SP Gyalshing, SDM (Hq), Welfare Officer Social Welfare Department (Gyalshing District), Deputy Director RDD Gyalshing, officials from Gyalshing Nagar Panchayat and Social Welfare Department Gyalshing and representatives from Banks.

During the meeting, deliberation on the assessment and needed intervention for strengthening of the enforcement mechanism imperative for protection of vulnerable communities of the district was emphasised. The house proactively delved on the needed intervention to strengthen the monitoring systems and make sure that effective implementation of both Acts are achieved across the district.

ADM Gyalshing in his keynote address to the house, emphasised on the strict enforcement of embedded legislations in the district. He advised stakeholders to ensure that swift and diligent efforts are maintained to efficiently address
