### State-level commemoration of 150 years of Vande Mataram



Gangtok, November 7: State-level commemoration of 150 years of Vande Mataram was held at Manan Kendra, Gangtok, today.

Organised by Culture Department in collaboration with Home Department, the event celebrated the legacy of India's National Song as a symbol of freedom, unity and devotion to the Motherland.

The occasion marked the formal launch of a year-long nationwide celebration from November 7, 2025 to November 7, 2026, commemorating 150 years of Bankim Chandra Chattopadhyay's composition that inspired India's freedom movement and continues to resonate with the nation.

The programme was attended by Governor Mr Om Prakash Mathur who inaugurated

the Vande Mataram Exhibition at the outset. Joining virtually from the Indira Gandhi Indoor Stadium, New Delhi, Prime Minister Mr Narendra Modi described Vande Mataram as not merely a song but a mantra and an expression of national unity that has inspired generations. He recalled how the verses, written in 1875, became a rallying call during the Swadeshi Movement. He urged the youth to carry forward the message of patriotism and national pride embodied in the song.

The Governor said that Vande Mataram is deeply rooted in the national consciousness and has inspired leaders including Lala Lajpat Rai and Bal Gangadhar Tilak. Recalling the words of Dr Rajendra

#### One-day training on AI tools for DPR preparation

Mangan, November 12: The Sikkim State Council of Science and Technology (SSCS&T), under the Department of Science and Technology in coordination Mangan with District Administration conducted a oneday training programme of the first batch of government officials on 'AI Tools for DPR (Detailed Project Report) Preparation' at the District Administrative Centre, Mangan, today. The second batch will be trained from November 13, 2025.

The training is being conducted under the theme 'Smart Proposals, Smarter Governance', highlighting the growing role of Artificial Intelligence in enhancing efficiency, accuracy and innovation in government project formulation and implementation.

The session was facilitated by Dr Prativa Rai Assistant Scientific Officer, SSCS&T and

the Master Resource Person, who led the participants through practical demonstrations and discussions on the use of AIbased tools for data analysis, report generation, proposal drafting and project monitoring. She was joined by officers of DST and other officials of the Department. The programme aimed to equip officers with digital competencies to streamline the preparation of DPRs and improve governance outcomes through technologyenabled decision-making.

The AI workshop for Government officials has been conceptualised by Dr Sandeep Tambe Principal Secretary, DST, and coordinated by Technology Transfer (IT) Division of Department of Science and Technology.

Government officials from various departments participated in the training, gaining valuable

insights into how AI applications simplify complex administrative tasks, reduce time in project development cycles and foster evidence-based planning.

Speaking on the occasion, Dr Prativa Rai emphasised on the integration of AI tools in DPR preparation, a step toward smarter governance enabling data-driven decisions, improving transparency and enhancing the quality of public projects.

The programme reflects the Sikkim State Council of Science and Technology's commitment to building digital literacy and promoting technological innovation within the State's governance framework. **Participants** expressed appreciation for the hands-on training and encouraged similar capacity-building initiatives in the future.

#### Mangan celebrates 150 years of Vande Mataram

Mangan, November 7: District Administration Mangan, joined the nationwide observance of the 150th anniversary of Vande Mataram with a mass singing programme, today.

The celebration was conducted in accordance with the Cabinet's approval on October 1 for country-wide commemoration aimed at reconnecting citizens especially students and youth with patriotic and revolutionary spirit of the iconic National Song.

Officers and staff of the DAC participated in the singing, using the official audio version issued by the Ministry of Culture platform through the vandemataram150.in. Similar mass activities singing simultaneously carried out across all Sub-Divisional Offices in the District, ensuring widespread involvement.

The programme underscored the historical and cultural significance of Vande Mataram, a song that inspired unity and courage during India's freedom movement. observance sought to honour this legacy and reinforce its message of national pride, unity, and collective identity among the present generation.

The event was led by Mr Pema Wangchen Namkarpa ADC Mangan accompanied by Mr Sandeep Kumar SDM Mangan and Heads of Departments.

On the occasion, SDM Mangan delivered a brief historical overview, highlighting that Vande Mataram originally a Sanskrit poem composed by Bankim Chandra Chatterjee in the 1870s and included in his 1882 novel Anandamath.

The commemoration reaffirmed the song's enduring

legacy in fostering a shared sense of devotion to the motherland and emphasised the importance of preserving such cultural heritage in the hearts and minds of future generations.

Similarly, to mark the commencement of the yearlong commemoration of the 150 years of Vande Mataram, the national song of India, in Gyalshing District mass singing was held at the premises of DAC Gyalshing.

On the occasion, the District Administrative Centre (DAC) Gyalshing led by Mr Tenzing D Denzongpa DC Gyalshing, accompanied by Mr Sonam Wangdi Bhutia Additional SP Gyalshing, ADC Gyalshing, SDM (Hq) Gyalshing, SDM Gyalshing, Heads of Offices and officials assembled at the DAC premises to sing the National Song.

DC Gyalshing termed the commemoration a significant milestone for the independent India. It is that on January 24, 1950, Dr Rajendra Prasad, President of the Constituent Assembly, declared 'Vande Mataram' the National Song of India, having played a historic role in the freedom struggle, he added.

He also mentioned that Bankimchandra Chatterji wrote 'Vande Matarm' during the auspicious occasion of Akshaya Navami, which was on November 7, 1875. Vande Mataram first appeared in his literary journal 'Bangadarshan' as part of Chatterji's novel 'Anandamath' in a serialised manner and later as a standalone book in 1882. During that period, India was undergoing major social, cultural and political changes and there was a growing consciousness of national identity and resistance to colonial rule.

#### DC Namchi chairs DTFI meeting

Namchi, November 6: Ms Anupa Tamling DC Namchi chaired the quarterly DTFI meeting with the Committe Members at DAC,

During the meeting, the DC briefed about the performance of the District till the 2<sup>nd</sup> quarter 2025-26, where it was highlighted that district has achieved around 50 % at par with annual target in child immunisation. It was also highlighted that till 2<sup>nd</sup> quater District has recorded zero maternal death and 99.2 % institutional delivery underscoring the quality of the medical services in the district.

Further, the Committee was also briefed on the PC-PNDT report, where it was mentioned that a total of 6 ultrasound clinics-1 Government clinic at District Hospital Namchi and 5 private clinic are operational within the District. She was also briefed on the recommendations of the State Advisory Committee, which are as follows:

 Discontinuation Existing inter- State practitioners (Ultrasound Users).

 Restriction on the Registration of inter- State Users. •Regular monitoring visits to clinics by District Monitoring Team. Strict compliance must be ensured and violation must be acted upon promptly by DAA.

Further, a NQAS report of the District was also presented to the DC where it was stated that various HWC PHCs and HWC SHCs have been certified under NQAS certification and various other institutes are under the targeted certification process. Additionally, four HWC-SHC certified NQAS Aspirational Block.

Prior to the meeting, the DC assessed about the present workforce strength and infrastructural capacities of the newly constructed District Hospital Namchi and also lauded the team for the smooth functioning of the hospital and advised them to further provide quality service to the public. She also advised all the members to provide correct data assesment of the reports and further adhere to the responsibilities towards their work.

The meeting also had the presence of Dr SN Adhikari CMO (Namchi), Dr BK Chauhan DRCHO Namchi, Mr Laxman Tamang CDPO (Namchi), CNO, Paediatrician (DHN), US (DHN), AD (Education) and other officers.
