# Ringhim Rikzing Choeling Monastery hosts silver jubilee celebration of Pang Lhabsol

Mangan, September 7: Ringhim Rikzing Choeling Monastery in Mangan witnessed the silver jubilee celebration of Pang Lhabsol, an annual festival organised in honour of Mount Khangchendzonga, the guardian deity of Sikkim.

This year the event was upscaled to mark the 25 years (silver jubilee) of the Pang Lhabsol Celebration in the Monastery. The occasion had the presence of HE Lachung Tulku Rinpoche, who led the prayers in the monastery. Likewise, Lepcha head priest Lavi Sangay performed the special ritual and invoked the guardian deity through the recitation of prayers and sacred offerings.

Mangan, September 6: A multidepartmental team commenced a high-altitude glacial lake expedition on August 20 with members from DMG, Sikkim Police, SSDMA, DDMA, SU, CWC, GSI, NIH, NIDM, CWPRS, HPSDMA, DGRE and IPR. The team was divided into groups: Team successfully completed its objectives at Dolma Sampa and Sora funnel area and returned on August 26, while Team B moved towards South Lhonak Lake. From there, sub-team B1 (CWC, GSI, NIH, HPSDMA and DGRE) returned to Gangtok on August 29 and sub-team B2 (DST, SU and IPR) advanced to Changsang before returning to Thangu on September 1. On September 2, Team B2 prepared for their move towards Yulhe Kangse Lake.

This scientific expedition marked the first-ever visit to

#### Glacial lake expedition

Yulhe Kangse Lake (16,378 ft) in North Sikkim, a milestone in the study of high-altitude Himalayan lakes and glacial environments. The exploration yielded valuable baseline data, including the lake's depth profile, sediment composition and potential linkages with regional hydrology and climate change contributing to a deeper understanding of fragile mountain ecosystems in the Eastern Himalayas.

On the 15<sup>th</sup> day of the expedition (September 3, 2025), the team departed from Thangu and reached Yulhe Kangse Base Camp for an overnight stay. The next day, September 4 (Day 16), they trekked to Yulhe Kangse Lake, where a traditional puja ceremony was held before commencing the first bathymetric survey and sediment sampling.

Continuing onward, the

team left Yulhe Kangse Base Camp on September 5 (Day 17), reaching Lachung for a night halt and on September 6 (Day 18) successfully returned to Gangtok, concluding this phase of the expedition. They returned with several interesting findings, which are expected to provide new insights into the geomorphology, hydrology and climate interactions of the high-altitude lake system.

The mission's success was made possible through the dedicated support of the Indo-Tibetan Border Police (ITBP), the Indian Army, the local Zumsa community and Khangri tours and trek whose cooperation ensured safety and smooth execution of this high-altitude scientific endeavor.

Pakyong, September 05: The District Hub for Empowerment of Women (DHEW), Pakyong District, under the Women, Child, Senior Citizen, and Divyangjan Welfare Department, organised the fourth day of its awareness programme at Rhenock Block Administrative Centre today.

The event was part of the ongoing 10-Day Special Awareness Campaign under SANKALP: Hub for Empowerment of Women, aimed at promoting health education, legal literacy, and gender awareness across the district.

The programme addressed key issues such as menstrual hygiene, anaemia, cancer awareness, mental health, and the provisions of the PCPNDT Act. It witnessed active participation from Gram Panchayat Unit (GPU) members, Self-Help Groups (SHGs), health and education officials, and community stakeholders.

Ms Mingma Lhamu Sherpa, Social Welfare Inspector, moderated the session and encouraged grassroots engagement. Ms Sanchita Sharma, Accounts Assistant, delivered the welcome address, setting the tone for inclusive dialogue.

Mrs Sabena Biswakarma, Counsellor and Resource Person from Rhenock CHC, delivered a detailed session on menstrual hygiene, anaemia, and cancer. She emphasised safe menstrual practices, the importance of ironrich nutrition to prevent anaemia, and early detection methods for breast and cervical cancer, encouraging proactive health management among women and girls.

Ms Sangita Pradhan, Counsellor from Rhenock CHC, highlighted the importance of mental well-being. Mr Alson Rai, Gender Specialist, spoke about the support services available through DHEW and urged participants to seek assistance whenever required. Ms Yanki Doma, Financial Literacy Specialist, provided insights into the Pre-Conception and Pre-Natal Diagnostic Techniques (PCPNDT) Act, a legislation

enacted to prevent sex-selective abortions and regulate diagnostic procedures.

Mr Jeewan Rai, Deputy Director from the Education Department, addressed the importance of student health and the need for mental health support in academic institutions, stressing the active involvement of parents and guardians.

The programme concluded with the distribution of sanitary pads to lactating mothers, adolescent girls, and women beneficiaries, reinforcing the campaign's commitment to dignity, health, and empowerment. Information, Education, and Communication (IEC) materials were also disseminated to strengthen community understanding of the topics discussed.

This initiative reflects the Government of Sikkim's continued efforts to strengthen women-centric services and promote inclusive development as part of the state's 50th year of statehood celebrations.

# Review meeting on establishing Digital Nomad Village

Soreng, September 5: Areview meeting on the proposed establishment of a Digital Nomad Village at Gumpa Dara, Soreng, was held today at the District Administrative Centre (DAC), Soreng, under the chairmanship of Mr DR Bista ADC-I.

In his address, ADC-I Mr DR Bista welcomed everyone and presented a detailed PowerPoint presentation on the proposed Digital Nomad Village at Gumpa Dara, highlighting the potential of this initiative to diversify the local economy, create employment opportunities for youth and promote sustainable tourism in the district.

The presentation included learnings from India's first Digital Nomad Village at Yakten, Pakyong District and how a similar model could be adapted in Soreng. The presentation further, provided an overview of Soreng's natural beauty, including panoramic views of Mt K hanchendzong a, monasteries, trekking routes, rich biodiversity and homestay culture.

He outlined the project's objectives, including the establishment of high-speed internet connectivity, coworking hubs, upgraded homestays, eco-friendly pathways and community-led cultural activities. The need for departmental convergence was also emphasised, with active participation from Departments such as Tourism, IT, Rural Development, Power, PHE, Health and Panchayats along with the private partners and homestay owners. The presentation further detailed the phased implementation plan, followed by infrastructure development, community training and pilot operations.

Additionally, the expected outcomes of the Digital Nomad Village were highlighted, including promotion of digital tourism, creation of sustainable livelihoods and support for

local entrepreneurs. The project is further complemented by its nearness to popular destinations such as Jhandi Dara, Rinchenpong Gumpa, Sai Mandir, Barsey Rhododendron Sanctuary, Singshore Skywalk Bridge, Solophok Char Dham, Samdruptse and Tathagata Tsal Buddha Park, he added.

In conclusion, he motivated and encouraged all stakeholders to actively participate in making the Digital Nomad Village at Gumpa Dara a reality. He emphasised that with coordinated efforts, community involvement and proper planning, the initiative could serve as a model for sustainable, inclusive and digitally connected development in Soreng.

General Manager (DIC) Mrs Anula Gurung provided a comprehensive briefing on the Prime Minister's Employment Generation Programme (PMEGP), a scheme funded by the Central Government. She gave detailed insights into the objectives and benefits of the scheme and guided the participants through the complete process documentation and application. Also, she assured all attendees of full support and assistance from the District Industries Centre.

The meeting also conducted an open discussion where various issues were raised and addressed, and the interactive session was effectively led by the concerned officials.

#### Workshop on Basics of ISL concludes

Gangtok, September 3: Two-day workshop on the Basics of Indian Sign Language (ISL) concluded at Soochna Bhawan, Information and Public Relations Department (IPRD), Gangtok, today.

Facilitated by the Composite Regional Centre for Skill Development, Rehabilitation and Empowerment of Persons with Disabilities (CRC Sikkim), Assam Lingzey, under the National Institute for Locomotor Disabilities, Kolkata, the valedictory programme witnessed the participation of special educators, special district coordinators, administrative assistants, teachers employees from both State and Central Governments.

The concluding day began with discussions on the role of Indian Sign Language in today's education sector, particularly in the context of the National Education Policy 2020 (NEP 2020). Deliberations were held on identifying children with special needs, importance of clinical psychologists, preparing Individualised Education Plans modification examination questions for children with special needs and methods of screening and assessment.

The technical sessions led by Mr Akhilesh Chauhan ISL

Master Trainer and Mr Vishal Biswakarma ISL Interpreter highlighted the use of technology in the field of ISL, the importance of facial expressions and body language, while addressing common misconceptions about sign language and deafness. Trainers also emphasised practical strategies to improve inclusivity in classrooms and workplaces through effective non-verbal communication. This was followed by an activity and Q&A session to further enable participants to clarify concepts and strengthen their learnings of ISL basics.

At the valedictory session, Ms Sarojini Subba Senior District Information Officer Gangtok, IPRD, lauded the workshop initiated by CRC Sikkim as a significant step towards fostering inclusive communication and accessibility for persons with special needs in Sikkim. Highlighting the efforts of the Government of Sikkim in promoting welfare of specially gifted children and inclusive education, she stressed the importance of understanding their unique needs and the role of such training in creating a more compassionate and responsive society.

Director CRC Sikkim, extended gratitude to Dr Lalit Narayan, Director NILD Kolkata for approving the programme that aimed at generating awareness among the non-disabled population and promoting inclusion.

# Training programme on NDPS Act and SADA

Gangtok, September 5: A two-day training programme on Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985 and the Sikkim Anti-Drugs Act (SADA), 2006 for Public Prosecutors and Investigating Officers commenced at Sikkim Police Headquarters, here today.

The training programme, being organised by the Law Department, Government of Sikkim in coordination with Home Department and Sikkim Police, aims at strengthening the professional capacities of law enforcement officers and prosecutors in effectively dealing with the complex challenges of narcotics-related crimes.

The inaugural session was attended by Mr Akshay Sachdeva, Director General of Police, Sikkim as chief guest, Mr Suraj Chettri LR-cum-Secretary, Law Department, Mr M Bharani Kumar Secretary Home Department, and Ms Rohini Pradhan, Additional Secretary-cum-Project Director, Sikkim INSPIRES.

DGP congratulated the Law Secretary and departmental team for curating training programme in coordination with the Home Department and Police Department describing it as a timely and relevant initiative in view of the growing challenges posed by the alarming rate of drug abuse cases in the state.

He expressed concern over the conviction rates in narcoticsrelated cases in the State, observing that while the criminal justice system is meant to ensure accountability, its credibility is weakened when offenders do not receive due penalties.

Acknowledging the challenges posed when pitted against seasoned defence lawyers, he stressed that it is the collective responsibility of investigating officers and prosecutors to build strong cases that can withstand scrutiny in court and ensure that those involved in drug-related crimes are held accountable.

DGP further stressed that investigating officers and prosecutors are the two wheels of the justice system, and their synergy is crucial to the success of cases under the NDPS Act and the SADA Act.

He expressed hope that the training would foster healthy debate, equip participants with sharper knowledge, and improve coordination between field investigation and courtroom prosecution.

Calling for a spirit of collective responsibility, he urged participants to set aside egos and work as a team to address the narcotics menace. He emphasised that while perspectives may differ, the overarching goal must remain the same, that is protecting society from the harms of drug abuse menace and ensuring Nasha Mukt Sikkim.

Earlier, LR-cum-Secretary, Law Department, highlighted the importance of equipping officers with legal and investigative expertise to effectively curb the growing menace of drug abuse in the state.

He underscored the alarming shift from softer to harder drugs among the youth, while highlighting the severe social impacts of substance abuse, including suicides and declining fertility rates.

Emphasising the Chief Minister's vision of a Nasha Mukt Sikkim, he called for stronger investigation techniques and an iron-fist approach in tackling the issue.

The training programme had the presence of Senior Police Officers, Investigating Officers, Public Prosecutors and resource persons from the Directorate of Prosecution, Narcotics Control Bureau, and Health Department.

The first day of the training featured a series of technical sessions covering various aspects of narcotics law and related issues.

The Directorate of Prosecution highlighted the salient features of SADA Act, 2006, including the classification of controlled substances, offences and penalties, and the powers of police officers.

This was followed by sessions from the Narcotics Control Bureau on the NDPS Act, 1985 and on emerging drug trends, which examined trafficking methods such as the use of courier services, darknet operations, crypto-funded logistics, organised crime networks, and the shift from soft to hard drugs.

Experts from Health and Family Welfare Department discussed mental health concerns linked to substance use, stressing the need for rehabilitation and psychological support.

The day concluded with an open discussion, wherein participants engaged with resource persons for clarifications and shared field-level experiences.

Pakyong, September 4: Chief Minister Mr Prem Singh Tamang and Chief Justice, High Court of Sikkim and Chancellor, Sikkim National Law University, Mr Justice Biswanath Somadder jointly attended the opening of the Sikkim National Law University at SICUN, Assam Lingzey, today.

Also present were Ms Justice Meenakshi Madan Rai, Mr Justice Bhaskar Raj Pradhan Judges, High Court of Sikkim, Mr Raju Basnet Minister for Education Department-cum-MLA Namcheybong, Mr Bhim Hang Limboo Minister for Labour Department, Ms Pamin Lepcha MLAGnathang-Machong constituency-cum-Advisor Women, Child, Senior Citizen and Divvangian Welfare Department, Dr Achina Kundu Vice Chancellor, Sikkim National Law University.

The University has been set up with the objective of providing opportunities to aspiring students from Sikkim and across the country, in the field of legal education. It lays particular emphasis on supporting meritorious students of Sikkim who wish to pursue a career in law but are often constrained by financial hardship and unable to study outside the state. The Sikkim National Law University offers BA LLB (Honours) and programmes and commenced its first academic session 2025–26 on September 1, 2025 with the inaugural batch of

Marking a milestone in the field of legal education and justice delivery, the Chief Minister in his address described the establishment of the University as not just the opening of an educational institution, but a historic step in strengthening justice, knowledge, and empowerment in Sikkim. He said the University would fulfil a long cherished dream of the people by enabling students to pursue quality legal education closer to home, nurturing a new generation of legal professionals who will contribute to the State and the nation.

He emphasised that the institution would serve as a hub of legal excellence, research and community service, instilling in students not only knowledge of law but also values of integrity, compassion and public service. 'This University should produce lawyers and scholars who have the courage to speak for the voiceless and uphold the Constitution in letter and spirit,'

he remarked.

The Chief Minister also expressed gratitude to Chief Justice and the judiciary for their guidance in turning this vision into reality. He acknowledged the contributions of Law Department, officials, and stakeholders whose efforts ensured successful establishment of the University.

It was announced that Prof Dr Achina Kundu has assumed charge as the first Vice-Chancellor of the University from August 1. 2024, while Ms Sonam Denka Wangdi has been appointed Registrar. Academic operations formally commenced from September 1, 2025, at Sikkim Judicial Academy, while the permanent campus has been identified at Assam Lingzey, with provisions made in the State Budget 2025-26 for its development.

Along with the launch, the Chief Minister announced several new measures to strengthen Sikkim's justice delivery system. These include the establishment of the Directorate of Prosecution and the Kanooni Sahyog Abhiyan, a campaign aimed at bringing legal services directly to people's doorsteps. He further emphasised the significance of Nari Adalat, introduced in August 2025, as a women-led forum offering community-based and accessible justice.

The initiative aligns with the vision of building a Sunaulo, Samridha ani Samartha Sikkim and Nasha-Mukta Sikkim, with a strong focus on empowering women, uplifting rural communities, and supporting youth and farmers. He expressed pride in Sikkim's No. 1 ranking among small States in India. Justice Report 2025, which assessed policing, women's representation, prison management, and judiciary. The meeting was attended by HoDs of line Departments, DC Gangtok, ASP Traffic and officials of concerned departments.

#### **Tourism and Civil Aviation** Department holds press conference

Gangtok, September 7: Mr CS Rao Additional Chief Secretary (ACS), Tourism and Civil Aviation Department along with Mr Neeraj Pradhan PCE-cum-Secretary, Ms Hondala Gyaltsen Secretary and Mr Tenzing Gelay Bhutia Additional Director addressed a press conference at the Mini Conference Hall of the Department,

ACS informed that Mangan District had remained closed to tourists since the end of May due to natural calamities. He stated that in coordination with the BRO, the Sanklang bridge had been inaugurated to restore connectivity to Dzongu. He added that the diversion reduces travel time by about one and a half hours for visitors going towards Chungthang. He confirmed that North Sikkim will reopen for tourists from September 8 and that online permits are being issued. He further informed that tourists can visit Lachung, Yumthang Valley and Zero Point, while Lachen will reopen in the next tourist season.

He said that tourists must cross the Sanklang bridge checkpost by 1:00 pm while proceeding and the Toong bridge by 2:00 pm while returning. He added that permits will be available online from Mangan or temporarily from the Chungthang SDM office.

He said that Union Defence Minister Mr Rajnath Singh had announced battlefield tourism on January 15, 2025. He added that Sikkim has three destinations under this initiative: Nathula, Chola and Doklam. He informed that after a meeting with the Chief Secretary, departmental Secretaries, Army officials and BRO officials, it was decided to open Chola and Doklam for domestic tourists from September 27, with an initial limit of 25 vehicles per day.

He further mentioned that on September 4, 2025, the North East Minister's Civil Aviation Conference-cum-3<sup>rd</sup> North East Aviation Summit took place at Itanagar, Arunachal Pradesh, under the chairmanship of the Minister of Civil Aviation, Mr Kinjarapu Ram Mohan Naidu. He said the meeting provided an opportunity to raise concerns about operations from Pakyong airport, to which Mr Naidu assured improved air connectivity. He added that the Government plans to bring in Boeing or Airbus aircraft, which will require extending the runway length by one kilometre, from 1.75 km to 2.75 km. He further stated that the Toong-Naga road is expected to be ready within two months. He concluded his address with gratitude to stakeholders of the tourism industry in the state for their cooperation.
