

4. Conduct of Departmental Meetings

- i. As far as practicable all scheduled departmental meetings shall be conducted through virtual mode. In cases where physical meetings are unavoidable, participation shall be ordinarily restricted to a maximum of two officials from each Department. Necessary support from NIC and IT Department may be obtained to strengthen Video Conference facilities.

5. Official Foreign Travel

- i. Official foreign travel by Government Officials shall be undertaken only under exceptional circumstance with the prior approval of the State Government.

6. Regulation of LPG Cylinder Distribution

- i. For monitoring and regulation of LPG cylinder distribution, Notification no. 363/LMU/F&CSD dated 26/03/2026 issued by the Food and Civil Supplies Department shall continue to be strictly complied with.
- ii. Allocation of additional LPG cylinders shall be granted only for marriage ceremonies and death rites.


7. Odd-Even Vehicle Restriction within Gangtok Municipal Area

- i. The Odd-Even vehicular movement restriction within Gangtok Municipal Area, as notified vide Notification No. 58/Transport/2024 dated 24/10/2024 shall continue to remain-in-force, until further orders.

This Notification shall come into force with immediate effect.

NOTIFICATION

In supersession of Notification No. 51/Home/2026 dated 14/05/2026, Notification No. 56/Home/2026 dated 31/05/2026 and Circular No. 01/Home/2026 dated 03/06/2026, **the State Government hereby withdraws all restrictions imposed on movement of Government vehicles across the State.** However, the following provisions as specified below shall continue to remain in force:

1. Carcade, Pilot Escort and Protocol Arrangements

- i. The Hon'ble Chief Minister has directed that the number of vehicles in his carcade shall be reduced by 50%, limiting the convoy to a maximum of five vehicles inclusive of the security vehicle.
- ii. The Hon'ble Speaker and the Hon'ble Deputy Speaker have decided that they shall not utilize Pilot Escort Vehicles during official tours except within Gangtok District only in connection with official functions.
- iii. As directed by the Hon'ble Chief Minister, all Protocol Courtesies relating to reception and see off by DCs, SPs during his official tours shall remain suspended.

2. Government Vehicles and Transport

- i. Fuel allotment (POL) for the official vehicles attached with the Hon'ble Chief Minister, Hon'ble Speaker, Hon'ble Deputy Speaker, Hon'ble Ministers, Hon'ble MLAs, and other Government Officers shall continue to remain reduced by 30%.
- ii. Purchase of new Government vehicles shall be prohibited, except for Police and Emergency Service vehicles.

3. Functioning of Government Offices

- i. All State Government Offices shall resume functioning with full staff strength and observe the usual six day working week, with the Second and Fourth Saturday as Government holidays.
